- Information security in terms of confidentiality, integrity and availability of relevant information is of central importance to our customers, suppliers, employees and other interested parties – and therefore also to us.
- The aim is to create, maintain and continuously improve framework conditions in order to protect information from unauthorised access in accordance with the state of the art, to ensure its accuracy and completeness, and to guarantee its necessary use at all times.
